- 4. The EU should not only support mecanisms for the creation of alliances and networks between European institutions but also between European and Asian institutions to overcome Eurocentric perspectives.
- 5. A new strategic framework for European scholarship on Global Asia will play a crucial role in determining how Europe successfully engages with a multi-centered and interconnected world.
- 6. This framework needs to reflect an evolution from merely competitive to collaborative co-creation of knowledge.
- 7. The transdisciplinarity of Global Asian Studies in Europe is relevant beyond higher education.
- 8. The strategic expansion of Global Asian Studies institutions and their partnerships in the Global South requires an EU-wide coordinated policy.
